RECOMMENDATION

It is recommended that the City Council adopt Council Bill #R-2020-08 - Confirming the City Manager/Director of Emergency Services' Proclamation of existence of a Local Emergency.

BACKGROUND

Pursuant to California Government Code Section 8630 and Loma Linda Municipal Code Section 2.28.060, on March 16, 2020 the City Manager, in his capacity as Director of Emergency Services, proclaimed an Emergency due to conditions of extreme peril to the safety of persons and property within the City as a consequence of the global spread of a sever acute respiratory illness caused by a novel (new) coronavirus ("COVID-19), including confirmed cases in the State of California and in San Bernardino County prompting the State of California and the County of San Bernardino to declare a local health emergency. On March 15, 2020, San Bernardino County Department of Public Health reported its first confirmed case of novel conoravirus.

This item requests the City Council review and ratify a Resolution confirming the Proclamation of Local Emergency issued on March 16, 2020 which empowered the Director of Emergency Services to make and issue rules and regulations on matters reasonably related to the protection of life and property as affected by such local emergency.

RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LOMA LINDA, CONFIRMING THE CITY MANAGER/DIRECTOR OF EMERGENCY SERVICES' PROCLAMATION OF EXISTENCE OF A LOCAL EMERGENCY

WHEREAS, the California Emergency Services Act, Government Code Sections 85589(c) and 8630 authorize the proclamation of a local emergency when conditions of a disaster or extreme peril to the safety of persons and property within the territorial limits of a city exist; and

WHEREAS, pursuant to Government Code Section 8630 such an emergency may be proclaimed by the governing body or by an official designated by ordinance adopted by the governing body; and

WHEREAS, Section 2.28.060 of the Loma Linda Municipal Code empowers the Director of Emergency Services/City Manager to proclaim a local emergency if the City council is not in session and requires that the City Council act to ratify the proclamation within seven days thereafter; and

WHEREAS, under provision of local law, if the City Council cannot be convened and, in the judgement of the Director of Emergency Services, the circumstances warrant it, he may issue a proclamation of local emergency which much be ratified or nullified by the City Council within seven days of issuance; and

WHEREAS, conditions of extreme peril to the safety of persons and property in the City of Loma Linda caused by epidemic in the form of the global spread of a severe acute respiratory illness caused by a novel (new) coronavirus ("COVID-19), including confirmed cases in the State of California and in San Bernardino County prompting the State of California and the County of San Bernardino to declare a local health emergency; and

WHEREAS, on March 4, 2020, California Governor Gavin Newsom issued a proclamation declaring a State of Emergency to prepare for, contain, and respond to mitigating the effects of, and recovery from, the spread of the COVID-19 virus (novel coronavirus 2019) in the state of California. The proclamation was introduced as the number of deaths and positive COVID-19 cases in California increased; and

WHEREAS, other provisions in the Governor's proclamation include the following:

• The 30-day time period in Health and Safety Code section 101080, within which a local governing authority must renew a local health emergency, is waived for the duration of the statewide emergency, and will remain in effect until each local governing authority terminates its respective local health emergency;

• The 60-day time period in Government Code Section 8630, within which local government authorities must renew a local emergency, is waived for the duration of the state emergency, and will remain in effect until each local governing authority terminates it respective local emergency; and

WHEREAS, the City Council does hereby find that the above described conditions of extreme peril did warrant and necessitate the proclamation of the existence of a local emergency; and

WHEREAS, the City Manager acting as the Director of Emergency Services did proclaim the existence of a local emergency within the City on the 16th day of March 2020; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Loma Linda that the Proclamation of Existence of a Local Emergency, as issued by the City Manager/Director of Emergency Services and attached hereto, is hereby ratified and confirmed; and

BE IT FURTHER RESOLVED, that this Resolution and the subject Proclamation shall remain in force and effect until the City Council of the City of Loma Linda terminates the local health emergency.

PROCLAMATION OF THE EXISTENCE OF A LOCAL EMERGENCY

WHEREAS, the California Emergency Services Act, Government Code Sections 85589(c) and 8630 authorize the proclamation of a local emergency when conditions of a disaster or extreme peril to the safety of persons and property within the territorial limits of a city exist; and

WHEREAS, pursuant to Government Code Section 8630 such an emergency may be proclaimed by the governing body or by an official designated by ordinance adopted by the governing body; and

WHEREAS, Chapter 2.28, Section 2.28.060 of the Loma Linda Municipal Code empowers the Director of Emergency Services to proclaim the existence or threatened existence of a local emergency when the city is affected or likely to be affected by a public calamity and the City council is not in session; and

WHEREAS, under provision of local law, if the City Council cannot be convened and, in the judgement of the Director of Emergency Services, the circumstances warrant it, he may issue a proclamation of local emergency which much be ratified or nullified by the City Council within seven days of issuance; and

WHEREAS, the City Manager, as Director of Emergency Services of the City of Loma Linda, in accordance with the authority provided under the above provisions of state and local law, does hereby find:

1, That the proclamation of a local emergency is warranted by virtue of the extreme peril to the safety of persons and property in the City caused by epidemic in the form of the global spread of a severe acute respiratory illness caused by a novel (new) coronavirus ("COVID-19), including confirmed cases in the State of California and in San Bernardino County prompting the State of California and the County of San Bernardino to declare a local health emergency.

2. That the City of Loma Linda officers and employees take all steps as requested by the City Manager and in accordance with the guidelines as prescribed by the Federal, State and County governments to prevent the spread of COVID-19 and to prevent or alleviate illness or death due to the virus.

3. That the City Council of the City of Loma Linda is not in session and cannot immediately be called into session.

4. That this proclamation shall be in effect for a period of seven days by which time it must be ratified by the City Council of the City of Loma Linda, pursuant to Government Code Section 8630.

NOW, THEREFORE, IT IS HEREBY PROCLAIMED that a local emergency now exists throughout the City; and

BE IT FURTHER PROCLAIMED AND ORDERED that during the existence of said local emergency, the powers, functions, and duties of the emergency organization of this City shall be those prescribed by state law, ordinances, and resolutions of this City, and by the City of Loma Linda Emergency Plan.

BE IT FURTHER PROCLAIMED AND ORDERED that all City officers and employees take all steps requested by the City Manager to qualify the City for reimbursement from the Federal Emergency Management Agency and for other state and federal relief as may be available to reimburse the City for the expenses it incurs in addressing this emergency.
